

# DOES YOUR GROUP USE THE CONCEPTS?

AA's Twelve Concepts for World Service are so practical. In none of our literature is there theory or dogma--only firsthand experience. Two good examples of such practicality can be found in Concepts III and IV. They contain two of the principles that Bill felt ought to be given the widest latitude in practice, the "Right of Decision" and the "Right of Participation." Concept III reads: "To insure effective leadership, we should endow each element of AA--the Conference, the General Service Board and its service corporations, staffs, committees, and executives--with a traditional 'Right of Decision." The "Right of Decision" has proved to be a most practical way for groups to empower delegates to the General Service Conference

to act in accordance with their conscience.

But the principles stated in the Concepts, like all our AA principles, are just as applicable in the home group. Our secretary, for example, is empowered through Concept III with the "Right of Decision." We trust in his thoughtful preparation to make announcements appropriate to our meetings--that is, announcements that are AA-related. We trust him not to announce, for instance, that Tom H. will be having a garage sale next weekend and hopes to see everyone there for great bargains-- come

early! We trust our program chair whose principal job is to book meetings. We don't tell her what groups or individuals to book but trust her to decide, based, for instance, on how recently a group has sent speakers to us and whether the group is within reasonable commute. Our hospitality team makes regular use of the spirit of the "Right of Decision." They determine what kind of refreshments the group will enjoy and do the buying.

I remember an incident some years ago at my then home group where the "Right of Decision" was a bit manhandled. The chair opened the meeting one night by announcing that the scheduled speaker had not shown up and instead of the usual discussion she had decided, on her own, to put together a three-speaker meeting. Afterward, several people let her know that they had been expecting their regular discussion meeting and were upset. She defended her decision by reminding them that, as chair, it was up to her to make decisions for the good of the group. She felt that the group needed "perking up." So she changed the meeting format.

Concept III states that "we ought to trust our responsible leaders to decide, within the understood framework of their duties, how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises." True enough, our chair had the final authority within the framework of her duties but by changing the meeting format she had overstepped her authority. Since a group, in its autonomy, decides on the format of its meetings through a legitimate voting process, she had unwittingly challenged the group's autonomy. I am happy to say that this trusted servant rethought the incident and became a wiser and consequently more valued member of the group.

As for Concept IV, the short form reads: "At all responsible levels, we ought to maintain a traditional 'Right of Participation,' allowing a voting representation in reasonable proportion to the responsibility that each must discharge." I recently witnessed a splendid example of the "Right of Participation" in action at a group in my area of which I was not a member. Opening a group inventory meeting, the chair requested that only members of the group participate; nonmembers could identify themselves but ought to refrain from commentary. If the chair had asked nonmembers to leave, I would have taken a grand-daddy of a resentment out into the night air. Instead, he invoked a very important part of the "Right of Participation" by recognizing my need to belong. I have also attended business meetings where the presiding officer announced that nonmembers were welcome to stay but must refrain from voting. Thus, thanks to the "Right of Participation," those of us who were not members were made to feel that we belonged, if not to that group, certainly to AA as a whole.

Participation, like the human body, comes in different shapes and sizes. I once heard a woman share at a meeting

that she was having a hard time staying sober and couldn't understand why. She said she had a home group and was "very active." What came to light was that most of her activity consisted of participation in outside endeavors, such as the PTA, Red Cross, a home for the elderly, and her neighborhood hospital. As for her AA membership, she attended meetings but did no more. What she didn't understand or had forgotten is that, while all those community activities are admirable, what we are talking about is participation in AA activities. Of course, none of us is forced to do anything in AA.

As Concept IV says, my participation in AA activities is a right. I may participate as a member of my group's steering committee or an ad hoc committee, or as an elected officer, or just as a member of the group. Or I may choose not to actively participate at all. But from the moment I declare myself a member of Alcoholics Anonymous, the right to participate in AA activities becomes and remains inalienably mine until the moment I remove myself from the Fellowship of Alcoholics Anonymous. Thanks be to Dr. Bob and Bill for their vision.

Are you aware of the Concepts at work in your home group? Why not hold a meeting to talk about them and their value to your group? If you do, it might be a good idea to announce it in advance. You might ask your GSR to lead it, or your area delegate. You might consider making available a supply of the Conference-approved pamphlet The Twelve Concepts Illustrated, as I have done for workshops. It is informative and what's more, people get a genuine kick out of the drawings. I love pictures, don't you?



## Get to know Area 4!

Our next Area Assembly is July 9th & 10th, 2022. It will be a hybrid meeting at Hole in the Wall Event Center in Conway and on ZOOM Email secretary@arkansasaa.org to ensure you receive updates regarding schedule changes.

#### Rules of Order at Area 4 Meetings

- Items for consideration are put on the agenda.
- Items are posed to the meeting in the form of a motion.
- All motions require a second.
- Motions can be amended, tabled, or moved to a vote.
- A vote is taken and the results are announced. The minority vote is allowed to voice its opinion.
- If a member of the majority (those who "won") wishes to change their vote, a second vote is held on the motion.
- The result of the second vote stands and the meeting moves to the next item for consideration.

#### What's the "Point "of Order?

- To ensure that all voices that wish to be heard are heard.
- To ensure that no one voice dominates all others.
- To ensure that everyone gets to speak once before another speaks twice.
- To ensure that everyone understands the content of the vote.
- To ensure that it is clear what actions were taken.
- To ensure a thorough record of the actions taken.

Motions requiring substantial unanimity of the meeting require a twothird majority for approval. In some cases, the minority opinion (the people who "lost" the vote) may be larger than 50% of the vote.




### A.A. GENERAL SERVICE OFFICE MOVES UPTOWN IN 1992

After 20 years on Park Avenue South, on Manhattan's East Side, G.S.O. New York relocates to 475 Riverside Drive. The date is March 1992. (Serendipitously, the 19-story limestone building was built by the Rockefeller family, so important to the Fellowship's early history.) The G.S.O. occupies the entire 11th floor, with The Grapevine offices one flight up. Every year, hundreds of A.A. members from around the world visit. A tour of the offices and Archives is provided to all visitors; no appointment is necessary.

# A.A.'S BIG BOOK HITS ANOTHER MILESTONE

The 70th publication anniversary of the Big Book, Alcoholics Anonymous, is marked in April 2009. # The Shopping Cart Mental Attitude:

Correcting My Neglectful Mental Shortcomings

Directionless and defeated, bankrupt in every department, ashamed of all my many failures, I drank myself into oblivion every day/night wondering if things were ever going to change and where it was all going to end. How I got to that state of decline was a mystery, after all, weren't my plans always noble? What went wrong? What went right is the question I should have been asking myself. I had painted myself into the corner of life, and the booze had come to the end of whatever comfort it had afforded me in the past. It was over for me and my flawed perception of life. Maybe I should try A.A., after all, what have I got to lose? (GOOD IDEA)

Amazed at what I heard in the meetings I was taking mental notes about how simple life was, and how my false vision of it in the past was my undoing. Maybe I should take a step back and not be in such a hurry to express my opinions, and to tell them how I do things. (GOOD START) Listening to the metaphors, similes, and clichés, was extremely helpful, in that it kept reminding me that I had to change my way of looking at things. In the past, I usually did just the opposite of the things they were suggesting. Trying to catch myself doing something that I knew to be wrong, and correcting it on the spot, became a mission for me.

One day, about forty years ago, while trying to find a parking space in a crowded lot at the market, I found one, and as I pulled into it, I found that someone had pushed a shopping cart into the flower bed, and it impaired my access. I was a little perturbed at this when it occurred to me that this is what I would have done in the past myself. Next, I removed the cart, parked my car, and returned the cart to the rack, and went on about my business. I have been doing this little discipline ever since and now, when I get out of my car, I almost always find a stray cart and return it to the Rack. This is just one of my efforts that symbolize the unselfish mental attitudes that I should have had all along. I make my bed daily, I allow drivers in front of me on the highway, and I open doors for people when the opportunity presents itself. These actions cost me nothing.

Today, my conscience is clear and I no longer loath myself. This is what is important to me these days. My old selfish way of thinking would have me take every advantage to get ahead in a material way, but I would suffer in a spiritual sense. I need to stay vigilant at that level or I may let my ego return to the driver's seat. Taking these disciplines into all my ventures of life has been a wonderful asset and I hope I never get complacent about these things.

Recently, I was handed an article from a sports newsletter written to instill character in the school sports programs and the writer commented that: "There are two kinds of people in the world, those that put the cart back in the rack, and those that make excuses for why they shouldn't have to do it." I mirthfully agree.

#### Editorial on the 7th Tradition

The A.A.. Groups themselves ought to be fully supported by the voluntary contribution of their own members. We think that each group should soon achieve its ideal: that any public solicitation of funds using the name of Alcoholic\* Anonymous is highly dangerous, whether by groups, clubs, hospitals or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spirtual heritage as futile disputes over properly, money, and authority.

Our growth continuing, the combined income of Alcoholics Anonymous members will soon reach the astounding total of \$250,000,000, a quarter of billion dollars yearly. This is the direct result of A.A. membership. Sober we now have it, drunk we would not.

By contrast, our over-all A.A. expenses are trifling.

For instance, the A.A. General Office now costs us \$1.50 per member a year. As a fact, the New York office asks the groups for this sum twice a year because not all of them contribute. Even so, the sum per member is exceedingly small. If an A.A. happens to live in a large metropolitan center where an intergroup office is absolutely essential to handle heavy inquiries and hospital arrangements he contributes (or probably should contribute) about \$5.00 annually. To pay the rent of his own group meeting place, and maybe coffee and doughnuts, he might drop \$25.00 a year in the hat. Or, if he belongs to a club it could be \$50.00. In case he takes The A.A. Grapevine he squanders an extra \$2.50!

So, the A.A. member who really meets his group responsibilities finds himself liable for about \$5.00 a month on the average. Yet his own personal income may be anywhere between \$200. and \$2,000. a month—the direct result of not drinking.

"But", some will contend, "our friends want to give us money to furnish that new club house. We are a new small group. Most of us are still pretty broke. What then"?

I am sure that myriads of the A.A. voices would now answer the new group saying, "Yes, we know just how you feel. We once solicited money ourselves. We even solicited publicly. We thought we could do a lot of good with other peoples' money. But we found that kind of money too hot to handle. It aroused unbelievable controversy. It simply wasn't worth it. Besides, it set a precedent which has tempted many people to use the valuable name of Alcoholics Anonymous for other than A.A. purposes. While there may be little harm in a small friendly loan which your group really means to repay, we really beg you to think hard before you ask the most willing friend to make a large donation. You can, and you soon will, pay your own way. For each of you these overhead expenses will never amount to more than the price of one bottle of good whiskey a month. You will be everlastingly thankful if you pay this small obligation yourselves.

When reflecting on these things, why

should not each of us tell himself, "Yes, we A.A.s were once a burden on everybody. We were 'takers.' Now that we are sober, and by the Grace of God have become responsible citizens of the world, why shouldn't we now about face and become 'thankful givers'! Yes, it is high time we did!".



#### Recovery



#### Step 7

Humbly asked Him to remove our shortcomings.

Step Seven is about getting rid of character defects and replacing them by practicing humility & spiritual principles. Working on the seventh step requires constant thoughtfulness and commitment to being honest, courageous and humble.



When working on steps four and five, we discovered our assets and shortcomings. With step six, we became prepared to deal with these qualities so that in step seven we could be ready to act.

Here are some questions to help guide you through Step Seven:

- How has my understanding of my higher power grown?
- How does being aware of my own humility help when working the seventh step?
- How do I plan to ask a higher power to remove my shortcomings?
- How does the spiritual principle of "surrender" work for me in step seven?
- Am I comfortable with prayer and meditation; even if it means making up my own?
- Have there been times when I have been able to stop from acting on a character defect and practice a spiritual principle instead?

#### Tradition 7

Every AA group ought to be fully self-supporting, declining outside contributions.

The paradox of A.A. is that financial independence and the support of our Fellowship by alcoholics and alcoholics alone not only enhances A.A.'s importance to each of us, but stimulates our engagement in our own recovery.

While the Fellowship has always faced problems of money, property, and prestige in one form or another, through the wisdom of the Seventh Tradition we have never been diverted from our primary purpose of carrying the message to the alcoholic who still suffers. This is our fundamental work, and to ensure that the hand of A.A. will always remain outstretched, money and spirituality must continue to mix. And for that, we are all responsible.

Honestly now, do I do all I can to help AA; my group, my central office, my GSO to remain self-supporting? Could I put a little more into the basket on behalf of the new guy who can't afford it yet? How generous was I when tanked in a barroom (or restroom)?

#### Concept 7

The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and A.A. purse for final effectiveness.

The charter and bylaws of the GSB are legal documents and those of the GSC are not. There may be times where the Conference has "gone off the deep end" and the Board needed to reel them back in through the vetoing of Conference action. The Trustees have "legal authority," where the Conference only has "moral authority."

#### Principle 7

#### Humility

Anonymity is real humility. It was only by repeated humiliations that we were forced to learn about humility. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility.

#### 7th Step Prayer

My Creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows.

Grant me strength, as I go out from here, to do your bidding. Amen.

The Preface to the Second Edition of the Big Book explains that revisions to the personal history section of the book were made in order "to represent the current membership of Alcoholics Anonymous more accurately, and thereby to reach more Alcoholics." In that spirit, the 2021 General Service Conference recommended that "a Fifth Edition of the Big Book, Alcoholics Anonymous, be developed, including an update of stories to better reflect the current membership, keeping in mind the 1995 Advisory Action:

"The first 164 pages of the Big Book, Alcoholics Anonymous, the Preface, the Forewords, 'The Doctor's Opinion', 'Dr. Bob's Nightmare", and the Appendices remain as is."

In response to the 2021 General Service Conference Advisory Action requesting the development of a Fifth edition of the book Alcoholics Anonymous, the trustees' Literature Committee is seeking a wide range of A.A. recovery experience of members in the Fellowship.

The trustees' Literature Committee is searching for recovery stories of our members for possible inclusion in the Fifth Edition which are from a broad cross-section of our local communities, all stories are of value. As Bill writes on page 29 of the book Alcoholics Anonymous: "Our hope is that many alcoholic men and women, desperately in need, will see these pages, and we believe that it is only by fully disclosing ourselves and our problems that they will persuaded to say, 'Yes, I am one of them too; I must have this thing.'"

It is the Literature Committee's shared hope that any new stories from our current membership will help future alcoholics to identify and find recovery in the pages of a Fifth edition.

The suggested format for typed manuscripts is 3500 words, double spaced, in 12-point font. Handwritten manuscripts should be approximately 5 to 6 pages.
